

## Updated Warranty Statement

If within ninety (90) days from the date of purchase, the product fails due to a defect in material or workmanship, Testing Timers Inc. will, at its option, repair or replace the product free of charge. This warranty applies only to original purchasers residing in the U.S., is non-transferrable, and is applicable only to products registered online via [www.testingtimers.com](http://www.testingtimers.com) within thirty (30) days of the date of purchase.
